ORDINANCE NO. 2009-01

AN ORDINANCE REGARDING THE BOARD OF REVIEW OF THE TOWN OF SAUKVILLE, ITS ORGANIZATION & MEMBERSHIP

THE TOWN BOARD OF THE TOWN OF SAUKVILLE, OZAUKEE COUNTY, WISCONSIN DOES ORDAIN AS FOLLOWS:

SECTION I:

- A. Purpose. The Board of Review of the Town of Saukville shall receive the annual assessment roll and hear objections by property owners of the assessment valuation of their property.
- B. Membership and Term of Office According to Wis. Stats. 70.46.
 - 1. The Board of Review shall consist of the following positions: two Town Supervisors, the Town Chairperson, and one resident citizen member; and an additional resident citizen shall be an alternate member.
 - 2. The Town Chairperson and Supervisor's terms on the Board of Review shall be conterminous with their elective terms as Supervisors.
 - 3. The citizen members shall be appointed to two-year terms.
 - 4. Nominations and appointments for the regular citizen and alternate citizen members of the Board of Review shall be made at the Town Board meeting held in April of each year.
- C. Board of Review Chairperson. The Town Chairperson shall preside over the meetings of the Board of Review except when the Chairperson is removed or recused pursuant to Wisc. Stats. 70.47 (6m), in which case the Board shall select a Chairperson *pro tem* to hear the objection in question.
- D. Quorum. Three members of the Board of Review shall constitute a quorum for the transaction of business except that two members may hold a hearing provided the requirements of Wisc. Stats. 70.47(9) are met for deliberations and action.
- E. Meetings. The Board shall meet at least once per year during the 30-day period beginning with the second Monday in May. All other meetings shall be at the call of the Chairperson according to Wis. Stats. 70.47.
- F. Duties. The Board shall have the powers and duties prescribed in Wisc. Stats. 70.47.

SECTION II: All other ordinances or parts of ordinances contravening the terms of this ordinance are hereby and to that extent repealed.

SECTION III: This ordinance shall take effect and be in full force upon its passage and the day after its publication.
